More details on the information we collect from third party sources such as the public, open source, BHA and racecourse officials, the press and bookmakers are set out in the BHA’s Integrity Privacy Notice.
- The British Horseracing Authority may share information relating to you with foreign racing authorities in other countries in relation to your licensing history. Some of these authorities may be located outside of the European Economic Area.
- We may also share information we receive from or about you with other third parties as set out in more detail in the Rider’s Agent Privacy Notice.
