Step 1 – Status and Location

- 1. Identify the correct horse
- 2. Click on the drop down menu next to 'Status'
- 3. Select 'Out of my Care or Control / Retired'

Please enter the name, address and email address of the new keeper of this horse. This information is collected so that the New Keeper can be made aware of their legal responsibility to complete a transfer of ownership with Weatherbys Stud Book within 30 days, in order to update the horse's passport. Failure of the New Keeper to do this could result in a fine of up to £5000 per offence. A copy of the relevant DEFRA Change of Ownership form can be found here

This information is required so that the new keeper can be made aware of their requirement to complete a transfer of ownership within 30 days, or they risk a fine of up to £5000 from Trading Standards under the Horse Passport Regulations.

If the racing owner intends to have ownership of the horse, and it is being rehomed on loan only, then you should provide the racing owner's details here.



Step 3 – Restrictions on Racing

- 1. Select the type of racing restriction that should apply to the horse
- 2. Select either 'The horse shall not be entered or participate in any race' OR 'The horse can enter and participate in point-to-point races only'
- 3. You must then indicate whether the horse could be reinstated in the future or whether the racing owner's permission would be required before a reinstatement process could begin (essentially this is a digital non-racing agreement).

THE HORSE SHALL NOT BE ENTERED OR PARTICIPATE IN ANY RACE
The Racing Owner will be notified of your intention to permanently retire the horse from racing. They will have 14 days to contest the retirement, after which time the horse will automatically:
Be prevented from being entered to run in a race under the Rules of Racing, and
Be prevented from having a Hunters' Certificate registered under the Point-to-Point Regulations
Please note that once complete, this ineligibility (retirement) will be permanent. A return to racing would require a formal reinstatement process at the discretion of the BHA.

THE HORSE CAN ENTER AND PARTICIPATE IN POINT-TO-POINT RACES ONLY
The Racing Owner will be notified of your intention to permanently retire the horse from racing. They will have 14 days to contest the retirement, after which time the horse will automatically:
Be prevented from being entered to run in a race under the Rules of Racing
The horse will be eligible to have a Hunters' Certificate registered under the Point-to-Point Regulations
Please note that once complete, this ineligibility (retirement) will be permanent. A return to racing would require a formal reinstatement process at the discretion of the BHA.
